3. Rules and Regulations

The ISSF World Cup will be conducted according to the actual ISSF Rules and Regulations. Detailed information is available on the ISSF website www.issf-sports.org.

ISSF Juries (Competition Jury, RTS Jury, and Equipment Control Jury) will be designated by the ISSF to supervise the ISSF World Cup. Qualified Range Officers / Referees holding applicable ISSF licenses will conduct the competitions.

Rifle / Pistol Equipment

Equipment Control will be conducted according to ISSF Rules using approved, calibrated instruments. Pre-competition testing is not mandatory, however, athletes are responsible for competing with legal equipment and clothing. All athletes are urged to submit any doubtful equipment and clothing to Equipment Control for checking before the competition. All athletes are subject to being selected for random post-competition testing and will be disqualified if their equipment or clothing is not legal according to ISSF Rules.

Rifle Clothing

All Rifle athletes must have ISSF seals with serial numbers on their jackets and trousers. Any jackets or trousers that do not have ISSF seals must be submitted to Equipment Control for inspection and the affixing of a seal before the athlete's first competition. Jackets and trousers that were previously inspected and have an ISSF seal continue to be valid except that athletes with more than one jacket or trousers must report to Equipment Control before their first competition to confirm which jacket and which trousers they will use. All other seal numbers for that athlete will be cancelled. Athletes that wish to replace a registered jacket or trousers with a new clothing item must bring that item to Equipment Control for inspection and a new seal. Previous seals will then be cancelled. Rifle athletes can have only one active jacket and trousers at any time.

Rifle Clothing Post-Competition Stiffness Testing

If one (1) panel of a rifle jacket or trousers tests 2.9 or lower, the stiffness device must be recalibrated and the panel must be retested. If it fails again, but all other panels pass, the athlete will not be disqualified, but a written warning must be given to the athlete and the ISSF seal must be cut off. The athlete can continue using this clothing for that day in that event. If two (2) or more panels fail, the athlete must be disqualified.

Air or CO₂ Cylinders

It is the athlete's responsibility to ensure that any air or CO₂ cylinder is still within its validity date. This may be checked by Equipment Control.

Shotgun Equipment

All Skeet athletes must have an ISSF seal with serial number on their Skeet marker tapes. Any shooting vests that do not have an ISSF seal on the Skeet marker tape must be submitted to Equipment Control for inspection and the affixing of a seal before the competition.

Equipment Control will be conducted according to ISSF Rules using approved, calibrated instruments. Pre-competition testing is not mandatory. However, athletes are responsible for competing with legal equipment and clothing. All athletes are urged to submit any doubtful equipment and clothing to Equipment Control or the Shotgun Jury for checking before the competition. All athletes are subject to being selected for random testing during the competition. Athletes found to be in violation of the rules for Shotguns or Skeet marker tapes will be disqualified.

Buttstock Height (for Skeet only)

The height of the buttstock (either adjustable or "Monte Carlo" type) measured from the highest point of the cheek rest to the lowest point of the butt plate toe must not exceed 170mm (17cm). Any butt plate toe vertical extension which is not an integral part of the buttstock and simply intended to increase its height, is not permitted.

Cartridge Control

During Qualification, athletes whose cartridges are to be tested are selected by a computer draw. Between 10% and 18% of the athletes participating in an event will be selected for cartridge testing. Two (2) plus four (4) cartridges will be selected from each athlete and placed in separate labeled envelopes. The two (2) cartridges must be tested first. If both cartridges weigh 24.50 g or less, no further action will be taken. If one (1) or both cartridges weigh more than 24.50g, then the four (4) cartridges in the second envelope must be tested. If the average of the six (6) cartridges weighs more than 24.50 g, then the athlete must be disqualified (DSQ).

During Final, all six (6) finalists must be tested using the same procedure. The Finalists or their Coaches/Officials must bring, as early as possible, but not later than 30 minutes before the scheduled start of the Final (Reporting Time), all the cartridges that will be used during the Final and place them in separate Cartridge Control Boxes on the Finals field of play. The Finalists must report at least 15 minutes before the start of the Final. The Equipment Control Jury will take the necessary samples from the boxes. The boxes must be left under the supervision of a Shotgun Jury Member. Once cartridges are placed in the box, only the Equipment Control Jury or the Finalist can remove cartridges from the box. If additional cartridges are brought to a Finalist during Finals, samples from those cartridges must also be selected for testing. All cartridge controls must be completed before the start of the Presentation of the Finalists. Any disqualified (DSQ) athlete will not be allowed to participate in the Final (There will be no elimination for 6th place; the first elimination will be for 5th place).

Colored Wads

Only transparent or translucent wads with no color may be used. Colored wads are prohibited.

Equipment Control

Equipment Control will be open to athletes according to the Competition Schedule.

4. Participation

Individual Events

ISSF Member Federations can enter a maximum of three (3) athletes per individual event who are competing for Medals. In addition, up to two (2) additional athletes per event can be entered to compete for Ranking Points Only (RPO).

Mixed Team Events

ISSF Member Federations can enter a maximum of two (2) teams per mixed team event, consisting of one (1) male and one (1) female athlete.

Maximum Entry / Range Capacity

The maximum number of starts per event is the number of athlete / mixed team entries that can be accepted for each event. Range capacity is determined by the available shooting time and the number of available firing points / ranges.

If the maximum number of starts is reached during the Final Entry process, a “waiting list” for that event(s) will be established. If cancellations are subsequently received, entries from the waiting list will be entered on a first come, first served basis.

ISSF and Organizing Committee will cooperate to determine if additional entries from the waiting list can be accommodated.

ISSF ID Number

All athletes must sign an "Athlete's Declaration" and have an official ISSF ID number issued before participation in the ISSF World Cup.

Athletes without ISSF ID number will not be allowed to participate. ISSF ID numbers can be obtained from the ISSF Headquarters by using the official application form.

Attention: Starting from 2025, all athletes, even with an official ISSF ID number already issued, must sign the updated "Athlete's Declaration" (Edition 2025) once again. Without renewed signature the athlete cannot be registered online and will not be allowed to participate in any ISSF Championship. The ISSF Headquarters communicated all details about this new procedure already in November 2025.

ISSF Member Federations are urged to ensure that all of their athletes who should be registered for the ISSF World Cup Lima 2025 have signed the updated declaration and returned it together with the a copy of the athlete's passport for verification purposes to the ISSF Headquarters at registration@issf-sports.org far ahead of the Final Entry Deadline.

5. Registration Process

Please complete the attached Registration Forms (Annex 1 – 6) and return them by the established deadlines (see also: "Summary of Deadlines").

Preliminary and Final Entries for Athletes and Officials must be done directly online by using the ISSF Online Registration System only. There are no separate Registration Forms available, any entries received by email will not be accepted.

Preliminary Entries

Late Entries

If the maximum number of athlete entries has not been reached, late entries will only be accepted until the **Late Entry Deadline** (3 days before the Official Arrival Day) which is **9 APR 2025**.

Important Note: Until the 3 days Late Entry Deadline, the following changes in the Final Entries are possible without restriction and additional fees:

- a) Change of names / athletes within an event
- b) Change of status ("Medal" athlete ↔ "RPO" athlete) within an event.

Any additional entries received after the Late Entry Deadline, from **10 APR 2025** onwards, may not participate.

Entry Confirmation upon arrival

All Team Leaders of participating ISSF Member Federations must report to the Organizing Committee Entries Official and confirm their Final Entries. The confirmation must be completed before 12:00h on the day before the Pre-Event Training.

Entry Changes after the Late Entry Deadline

From **10 APR 2025** onwards, only the following changes in the Final Entries are permitted:

- a) Replacement of a registered athlete by another already registered athlete (in another event) can be made only before 12:00h on the day before the Pre-Event Training for that specific event.
- b) Status exchange between a registered athlete for competing for Medals and a "RPO" athlete can be made only before 12:00h on the day before the Pre-Event Training for that specific event.

Cancellation

Any ISSF Member Federation that reduces the number of athletes and / or officials after the Final Entry Deadline (**14 MAR 2025**) must pay all applicable entry fees and hotel room cancellation costs according to the number of athlete and official entries originally received. If the applicable fees and costs are not paid, no member of that federation may participate.

Entry Fees

The entry fees include all charges for registration, local transportation between shooting range and official hotels and doping control.

The entry fees include one (1) round of Pre-Event Training for Shotgun.

They DO NOT include additional costs for Pre-Event and Unofficial/Official Training.

Payment of Entry Fees

All entry fee payments must be made in cash, in **EUR (€) or USD (\$)**, to the Organizing Committee upon arrival at the shooting range.

Payments at the shooting range will start being accepted from 10 APR 2025.

Payments made by credit or debit card will have a 5% transaction fee. Traveler's checks are NOT accepted.

Payments by bank transfer will ONLY be possible if the payment is done at least 15 days before the arrival date. The federations making the bank transfer payment must indicate the country abbreviation to allow us to identify it.

A copy of the transfer document must be sent to the Organizing Committee by **13 MAR 2025**.

Accreditation Process

All persons involved in the ISSF World Cup (Athletes, Team Officials, ISSF Officials, OC Officials, Media Persons, ...) must have accreditations that clearly identify the accreditation holder (with photograph, family name and first name, country and function) in order to use the local transportation and to enter controlled areas on the shooting range.

Accreditations (for persons registered before the Late Entry Deadline) will be prepared in advance by the ISSF and Organizing Committee. During the online registration process, the ISSF Member Federations can upload pictures of their athletes and officials to be displayed on the accreditations. **There will be no possibility to take photos for accreditations on the shooting range.**

Accreditations and BIB Numbers will be distributed by the Organizing Committee after payment of the entry fees.

The Skeet ranges operate with acoustic release system.

All ranges are equipped with Elettronica Progetti electronic scoreboards.

The firing direction of the shooting range is south-east.

The targets used for the ISSF World Cup are eco-friendly from Laporte, standard orange for the Qualification and flash orange for the Finals.

7. Immigration and Customs Requirements

Visa

Participants must fill and send the **Visa Support Form (Annex 5)** as early as possible, but not later than **13 MAR 2025** to receive the nominative invitation letter which can help to obtain the visa.

All nations that need an official invitation from the Peruvian National Sport Shooting Federation, must request it before **13 MAR 2025** (Annex 5). Please send an email to the Organizing Committee, requesting it.

Unless the Organizing Committee receives a special request, the invitation will be sent by email. If an express service is requested, the cost of this service will be charged to the federation and must be paid to the Organizing Committee upon arrival.

The Peruvian National Sport Shooting Federation has no influence over the embassies and can provide invitations **for the period of the ISSF World Cup Lima 2025 only**.

PLEASE TAKE INTO CONSIDERATION THAT BY NATIONAL REGULATION IT'S MANDATORY THAT THE PASSPORT IS VALID FOR SIX (6) MONTHS UPON ENTERING PERU.

Gun License

All nations must be in possession of the approved Firearm and Ammunition Form (Annex 6), certified by the Peruvian authorities. Be sure to bring a copy of your certified Firearm and Ammunition Form with you. In addition, it is recommended that all delegations carry a list of all firearms and ammunition, which will be presented to customs agents, upon request, along with the invitation.

Please fill in the form completely, do not change the form or use your own form. Incomplete forms cannot be accepted and will be sent back. The completed forms must be submitted to the Organizing Committee by email no later than **13 MAR 2025**.

It is MANDATORY BY LAW that all firearms, including compressed air guns, must be declared, as well as their ammunition (12GA, .22LR & 4.5mm).

The requirements for the temporary import of firearms:

1. Fill out (LEGIBLE LETTER) the Sucamec - Affidavit Form for each athlete (one from per firearm)
2. ISSF World Cup Invitation
3. Passport scanned photo
4. Gun license scanned photo
5. Property card scanned photo
6. If an athlete travels with firearms of its Federation, he/she must attach a document of the same.
7. The flight itinerary of entry and exit of the country is important.

The cost for the firearm registration process is EUR 50.00 per firearm.

IMPORTANT: FIREARMS AND AMMUNITION MUST GO DIRECTLY TO THE ARMORY OF THE SHOOTING RANGE. NO TYPE OF FIREARMS, INCLUDING AIR GUNS, WILL BE ALLOWED TO TRANSFER THEM TO THE HOTEL OR OUTSIDE THE SHOOTING RANGE.

IT IS IMPORTANT THAT ALL YOUR FIREARMS ARE PRESENTED TO CUSTOMS! IF THERE IS NO OFFICIAL PRESENT WHEN YOU GO THROUGH THE "CUSTOMS AREA", YOU MUST CONTACT THE ORGANIZING COMMITTEE AND REQUEST AN OFFICER. IF YOU DO NOT DO SO AND DO NOT SHOW YOUR FIREARMS TO A CUSTOMS OFFICER ENTERING PERU, YOU WILL HAVE PROBLEMS WHEN YOU LEAVE THE COUNTRY AGAIN.

Technical Meeting

Storage of Firearms and Ammunition

During your stay in Peru, for the ISSF World Cup Lima 2025, all firearms and ammunition must be stored in the armory at the shooting range.

It is strictly prohibited to take any firearms and ammunition out of the shooting range.

The armory will be open from 06:30 to 19:00. Every day the armory staff will check to confirm that all firearms and ammunitions are returned to the armory after training / competition.

The federations that wish to arrive earlier than **13 APR 2025** or leave later than **22 APR 2025** must pay an additional fee to use the armory, which is **EUR 100.00** per federation. This fee must be paid to the Organizing Committee.
